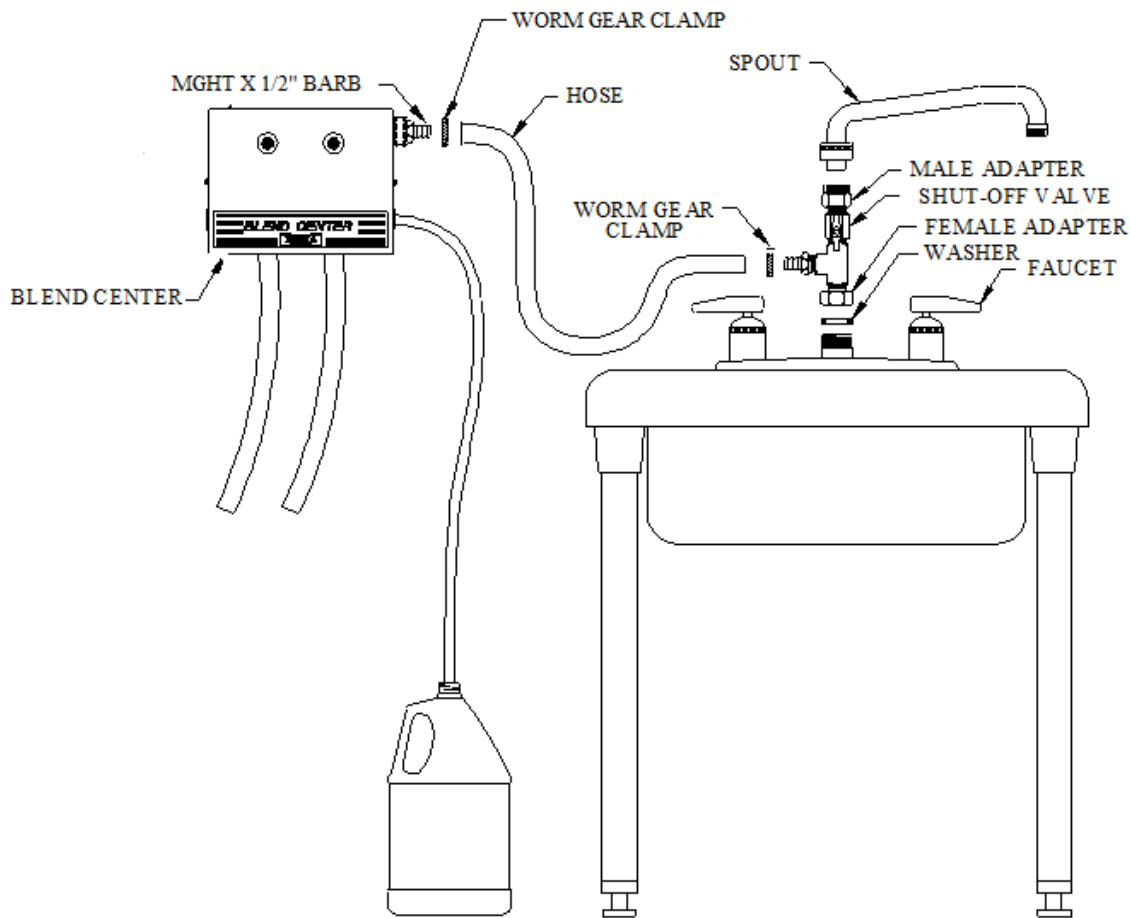

2. INSTALLATION:

Remove the spout from the faucet and tighten the manifold assembly onto the faucet using a rubber sealing washer. Next, attach the spout to the top of the manifold assembly and push the hose and clamp onto the male hose barb and tighten. Attach the MGHT x 1/2" barb to the dispenser. Attach the other end of the hose and clamp to the MGHT x 1/2" barb fitting.

NOTE: Do not remove the o-ring from under the sink spout.
